Afterschool Labs:

Package Options: Parents have the option to choose between the following packages for their child:

The “Elite Achievers” Package:

- ❖ **Tuesday – Math Tutoring:** Personalized math tutoring sessions to provide support and address specific areas where children may need help.
- ❖ **Thursday – Reading Tutoring:** Tailored reading tutoring to enhance literacy skills, guided by input from teachers and/or parents.
- ❖ **Cost: \$30 per week per child**

The “Goal Getter Gang” Package:

- ❖ **Monday – Financial Literacy:** In this session, we focus on instilling valuable financial knowledge and skills, helping children understand the importance of money.
- ❖ **Wednesday – Executive Functioning and Emotional Intelligence:** Concentrating on essential life skills, including organization, problem-solving, and emotional awareness.
- ❖ **Cost: \$30 per week per child**

The “Creme de la Creme” Package:

- ❖ **Friday –Law, History, and Heritage:** a day of enjoyable activities that teach kids about laws, history, and their roots, helping break the cycle of poverty by empowering them with knowledge and a broader perspective.
- ❖ All five days of the afterschool program (Monday to Friday)
- ❖ **Cost: \$50 per week per child**

Tuition Payment Policy

I, the undersigned, acknowledge and agree to the following payment terms:

- A one-time **non-refundable registration fee of \$50 per child** is applicable upon enrollment.
- The **registration fee is waived if I opt for automatic payment** (autopay) for tuition. To enroll in autopay, I will contact the program administrator to set up automated payment arrangements.
- Tuition payments for the afterschool program are **due each Friday in advance** of the upcoming week.
- If I miss the payment deadline for one Friday, a **late fee of \$5 per child** will be assessed.
- If two consecutive Fridays pass without payment, my child will not be allowed to return to the program until all outstanding dues are **paid in full**.
- If no payments have been made for a period of 30 days, my child will be **removed from the program**. In such cases, I will be required to pay a new registration fee when spots become available for re-enrollment.
- **It is my responsibility** to ensure timely and accurate payment of tuition fees.
- Elite Academy reserves **the right to enforce this policy** to maintain the financial stability of the program.
